PPS PUBLISHES QUARTERLY STATISTICAL BULLETIN

The Public Prosecution Service (PPS) today published its Quarterly Statistical Bulletin. It provides information for the first quarter of the 2013/14 financial year (1 April to 30 June 2013) and includes comparisons for the equivalent period in 2012/13.

The bulletin presents key statistics on the activity of the PPS, including caseloads and prosecutorial decisions. It now also includes data on the outcomes of prosecutions at court.

Key findings

During the first quarter of the 2013/14 financial year:

- The PPS received a total of 12,144 files. This was a decrease of 9.8% on the corresponding quarter of 2012/13 (13,461).
- All recorded crime offence groups have shown a reduction in the number of files received compared with the corresponding quarter of 2012/13.
- Of the total files received, 331 were submitted by government departments and agencies, the majority of which were from the Department for Social Development (44%) or the Driver and Vehicle Agency (30%).
- 15,295 prosecutorial decisions were issued by the PPS. The Test for Prosecution was met in the majority of cases; more than seven-tenths (72%) were issued with a decision for prosecution (9,342) or for diversion from the courts (1,708). This was marginally lower than the equivalent period in 2012/13 (73%).
- There was a decrease of 3.9% in the number of decisions to prosecute. This comprised of a 4.1% decrease in summary prosecution decisions issued and a smaller decline of 0.7% in indictable prosecution decisions. The numbers of diversionary decisions fell by 6.1% while no prosecution decisions increased by 1.6%.

- Of the 4,245 decisions for no prosecution, the vast majority (96%) did not pass the evidential test. The remaining 4% did not pass the public interest test.
- The average number of calendar days required for issue of a decision varied by type. Indictable prosecution decisions were issued in an average of 171 days, summary prosecution decisions in 20 days, informed warnings in 25 days, restorative cautions in 16 days and youth conferences in 16 days. Average days to issue included time taken by the police to respond to decision information requests and for case preparation.
- 738 defendants were dealt with in the Crown Court. This was an increase of 39.5% on the equivalent period in 2012/13 (529). The conviction rate in the Crown Court was 83.9%.
- A total of 8,294 defendants were dealt with in the Magistrates' and Youth Courts, a decrease of 15.3% on 2012/13 (9,797). The conviction rate in the Magistrates' and Youth Courts was 80.3%.
