I refer to your email dated 16 May 2025 in which you requested information regarding protest related offences. Your request has been dealt with under the terms of the Freedom of Information Act 2000.

Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked the following:

"We request that the PPS disclose the following information from 1 May 2022:

- 1. The quantity of prosecutions, convictions and decisions not to prosecute for protest- or parade-related offences, delimited by:
 - a) Subject-matter of protest or parade;
 - b) Offence:
 - c) Outcome:
 - d) Gender identity of person arrested, charged, prosecuted or convicted; and
 - e) Race/ethnicity of person arrested, charged, prosecuted or convicted.

By a 'protest- or parade-related offence', we mean both (1) offences relating to the holding of an unauthorised parade or protest meeting; and (2) offences committed during a protest, or immediately before or after a protest".

In response to question 1(a), please be advised this information is not held in a format which can be easily extracted from the PPS Case Management System (CMS). Therefore, to answer your request accurately would require a manual search of all cases and would easily exceed the cost limit as defined in Section 12 of the Act which makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit; for the PPS as a Government Department the limit is set at £600. This represents the estimated cost of one person spending 3.5 working days in determining whether the department holds the information, locating, retrieving and extracting the information.

In response to questions 1(b) -1(d), please see **Tables 1 and 2** below which detail the numbers of prosecution / diversionary / no prosecution decisions issued for unlawful / un-notified processions related offences for the period 1 May 2022 - 30 April 2025, as well as Magistrates' Court outcomes over the same period. Please note that there were no Crown Court outcomes relating to these offences.

Offences considered in the analysis are provided at **Annex A**.
