I refer to your email dated 11 April 2025 in which you requested information. Your request has been dealt with under the terms of the Freedom of Information Act 2000.

Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked the following:

"I am writing to request the following information under FOI:

- The number of cases referred to the PPS by the PSNI relating to human trafficking offences in each of the last 10 years. Please provide a breakdown by type of exploitation.
- 2. The number of human trafficking cases prosecuted by the PPS in each of the last 10 years. Please provide a breakdown by type of exploitation.
- 3. The outcome of human trafficking prosecutions (conviction, acquittal, discontinued) in each of the last 10 years.
- 4. Sentencing outcomes for individuals convicted of human trafficking offences in each of the last 10 years.
- 5. The number of cases referred to the PPS relating to the purchase of sex since June 1st, 2015.
- 6. The number of prosecutions related to the purchase of sex since June 1st, 2015.

7. The outcome of prosecutions related to the purchase of sex (conviction, acquittal, discontinued)".

In response to questions 1-3, please see Tables 1-3 below which detail the number of files referred to the PPS, the number of prosecutions and outcomes in respect of human trafficking offences for the period 2015 - 2024. It is not possible to provide a breakdown by type of exploitation as the numbers are too low and would therefore risk disclosure of personal information.
