I refer to your email received by the PPS on 12 March 2018 in which you requested information regarding convictions for murder and attempted murder.

This request has been dealt with under the terms of the Freedom of Information Act 2000.

You had asked for the following for each calendar year for the last five years:

- 1. How many men and how many women have been convicted of murder and attempted murder?
- 2. In each case, did they plead guilty or not guilty?
- 3. In each case, can you tell me the total custodial sentence they received?

In response to questions 1 and 2, please see attached **Table 1** detailing the overall court outcomes in cases involving murder and attempted murder over the five year period 2013 – 2017 inclusive. **Tables 2** and **3** detail the breakdown for male and female defendants. All statistics should be read in conjunction with the explanatory notes, which are set out in the various worksheets

In respect of question 3, whilst data are held on outcomes in relation to cases involving murder and attempted murder, the PPS cannot provide an analysis of sentencing in respect of these offences. However this information may be available from the department of Justice / NI Courts and Tribunals Service.

If you are dissatisfied in any way with the handling of your request under the Freedom of Information you have the right to request a review in accordance with our review procedure. In the event that you require a review to be undertaken, you should do this as soon as possible or in any case within two months of the date of this response by writing to the Head of Policy & Information, Public Prosecution Service, Belfast Chambers, 93 Chichester Street, Belfast BT1 3JR or alternatively by sending an e-mail to info@ppsni.gov.uk. You should state clearly the grounds on which you are requesting the review.
