I refer your email dated 3 June 2020 in which you requested information held by the Public Prosecution Service in respect of offences under the Terrorism Act. Your request will be dealt with under the terms of the Freedom of Information Act 2000.

Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked for:

"I'd like to see the number of people charged with, as well as the number of people ultimately convicted of, the offences listed below over the time period ranging from the first of January 2010 through to the end of December 2019, broken down by calendar year.

Please provide this data for the following offences:

- s.58(1) of the Terrorism Act 2000
- s.57(1) of the Terrorism Act 2000
- s.2(1) of the Terrorism Act 2006
- s.5(1) of the Terrorism Act 2006"

In response, please see tables below detailing prosecutorial decisions issued for specified Terrorism Act offences between 01/01/2010 and 31/12/2019 (Table 1), as well as data in respect of defendants dealt with in the Crown Court during the same period (Table 2). Offences included in the analysis are listed at Table 3. The tables should be read in conjunction with the accompanying notes.

It should be noted that the data in respect of Tables 1 and 2 are based on *separate* analyses. Table 1 reflects the year in which the prosecutorial decision was taken and Table 2 reflects the year in which the defendant was dealt with in the Crown Court.

If you are dissatisfied in any way with the handling of your request under the Freedom of Information Act, you have the right to request a review in accordance with our review procedure. In the event that you require a review to be undertaken, you should do this as soon as possible or in any case within two months of the date of this response by writing to the Head of Policy & Information, Public Prosecution Service, Belfast Chambers, 93 Chichester Street, Belfast BT1 3JR or alternatively by sending an e-mail to info@ppsni.gov.uk.
