I refer to your email dated 13 June 2018 in which you asked for statistics on prosecutions relating to abuse / assault where the victim was a member of Northern Ireland's emergency services.

Your request has been dealt with under the terms of the Freedom of Information Act 2000.

## Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked for the following:

- "1. Figures for the number of prosecutions initiated in cases of abuse/assault, both physical and verbal, in which the victims were members of Northern Ireland's emergency services (ambulance/fire/police) in each year from 2013 to the present date.
- 2. Could you also give a breakdown of how many of these prosecutions resulted in a conviction, and how many ended up in acquittals or where the case was thrown out etc?
- 3. In the case of a conviction, could you also give details of the sentence handed down."

In response to question 1, please note that it is not possible to identify cases where emergency services personnel have been the victim of abuse / assault, as the occupation of the victim is not recorded on the PPS Case Management System.

However a number of specific offences exist in respect of certain categories of emergency services personnel / related offences, namely Assault on Police and Assault on an Ambulance Worker, as follows:

Data in respect of these offences have been provided as an alternative. Table 1 below, details the prosecutorial decisions issued for these offences between 1/1/13 and 27/6/18. It should be noted that prosecutions in respect of these offences are usually directed by the PPS where the assault was relatively minor in nature. More serious incidents, where injury has been caused, would be dealt with for example as Assault Occasioning Bodily Harm, Grievous Bodily Harm etc. As outlined above, it is not possible to identify such incidents.

In response to question 2, Tables 2a and 2b detail the outcomes of prosecutions in the Crown Court (indictable prosecution decisions) and the outcomes of prosecutions in the Magistrates' Courts (summary prosecution decisions) – i.e. for cases involving Assault on Police / Assault on an Ambulance Worker.

In respect of question 3, whilst data are held on outcomes, the PPS cannot provide an analysis of sentencing in respect of these offences. However this information may be available from the NI Courts and Tribunals Service.

All statistics should be read in conjunction with the explanatory notes.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review in accordance with our review procedure. You should do this as soon as possible or in any case within two months of the date of this response and you can do so by writing to the Head of Policy and Information Unit, Public Prosecution Service, Belfast Chambers, 93 Chichester Street, BELFAST, BT1 3JR or alternatively by sending an e-mail to info@ppsni.gov.uk. You should state clearly the grounds on which you are requesting the review.
