I refer to your email dated 6 September 2018 in which you requested statistics relating to The Sexual Offences (Northern Ireland) Order 2008.

This request has been dealt with under the terms of the Freedom of Information Act 2000.

## Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked the following:

"Can the PPS please provide details of how many people have been prosecuted and how many successful convictions under Section 32 and 33 of the Sexual Offences (Northern Ireland) Order 2008 there have been in each of the last three years (or from 2008 when the Order was introduced)?"

In response please see attached Table 1 detailing prosecution decisions issued by the PPS in respect of offences under the Sexual Offences (Northern Ireland Order) 2008. Decision data have been provided from 2010, the earliest year for which statistics are available.

Table 2 details the overall outcomes in the Crown Court for defendants dealt with in respect of offences under the 2008 Order. Data in respect of court outcomes are available for the period from 1 April 2012 to 30 June 2018 only. No defendants were dealt with in the Magistrates' Court over this period.

A list of all of the offences considered is also provided.

If you are dissatisfied in any way with the handling of your request under the Freedom of Information Act you have the right to request a review in accordance with our review procedure. In the event that you require a review

to be undertaken, you should do this as soon as possible or in any case within two months of the date of this response by writing to the Head of Policy and Information, Public Prosecution Service, Belfast Chambers, 93 Chichester Street, Belfast BT1 3JR or alternatively by sending an e-mail to info@ppsni.gov.uk. You should state clearly the grounds on which you are requesting the review.
