I refer to your email dated 11 May 2021 in which you asked for information regarding prosecutions brought by the PPS under the Coronavirus Act 2020. You later confirmed that you wished to receive details of all Covid-19 related offences, for example those relating to the various Health Protection Regulations.

Your request has been dealt with under the terms of the Freedom of Information Act 2000.

Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked the following:

"The number of successful court approved prosecutions using The Coronavirus Act 2020 between April 2020 - April 2021 (12 months) and

The number of unsuccessful Coronavirus Act 2020 prosecutions with the case getting dismissed in court between April 2020 - April 2021 (12 months)".

In response, please see table below detailing the Magistrates' and Youth Court outcomes for defendants dealt with over the period 1 April 2020 - 31 March 2021.

As at 4 June 2021, the total number of defendants dealt with in respect of Covid-19 related offences stood as 99, including 86 convictions, 2 acquittals and 11 other outcomes. Prosecution decisions have been issued for a further 142 defendants and these cases are pending disposal in the courts.

Please note that all data are sourced directly from the PPS Case Management System and remain *provisional* at this stage.
