I refer to your email dated 31 October 2018 in which you asked for the statistics on who has been reported, prosecuted or criminalised for having had, attempted to have, or forced someone else to have, an abortion in Northern Ireland.

Your request has been dealt with under the terms of the Freedom of Information Act 2000.

Freedom of Information Act 2000

The Freedom of Information Act creates rights of access for any person making a request for information to a public authority. The rights of access are twofold. First, to be informed by the public authority if it holds information of the description specified in the request, and if that is the case, secondly, to be provided with that information. These rights are subject to important limitations, which are designed to achieve a proper balance between the right to know and considerations of law and policy in the broader public interest.

You had asked for the following:

"The statistics on who has been reported, prosecuted or criminalised for having had, attempted to have, or forced someone else to have, an abortion in Northern Ireland".

In response please see Table 1a below detailing files received between 1 January 2010 and 7 November 2018 in respect of offences related to abortion In Northern Ireland.

Table 1b details prosecutorial decisions issued by the PPS between 1 January 2010 and 7 November 2018 in respect of the requested offences and Table 1c details prosecution decisions made for offences other that those related to abortion for the same period.

Table 2a and Table 2b details the overall outcomes in the Magistrates' Courts and Crown Courts respectively for defendants dealt with under the requested offences on files received between 1 January 2010 and 7th November 2018.

A list of all of the offences considered is also provided in Table 3.

If you are dissatisfied in any way with the handling of your request, you have the right to request a review in accordance with our review procedure. You should do this as soon as possible or in any case within two months of the date of this response and you can do so by writing to the Head of Policy and Information, Public Prosecution Service, Belfast Chambers, 93 Chichester Street, BELFAST, BT1 3JR or alternatively by sending an e-mail to info@ppsni.gov.uk. You should state clearly the grounds on which you are requesting the review.
